- Thursday, October 6, 9:00 AM

All meetings of the Community Advisory Committees for Haywood County are held in the Conference Room at the Haywood Senior Resource Center, 81 Elmwood Way, Waynesville, NC.

As a general rule the following guideline is in practice as it relates to weather: "In the event the local (county) school system is altered (closed or delayed start) due to weather related reasons the meeting will be postponed and rescheduled for a later date."
